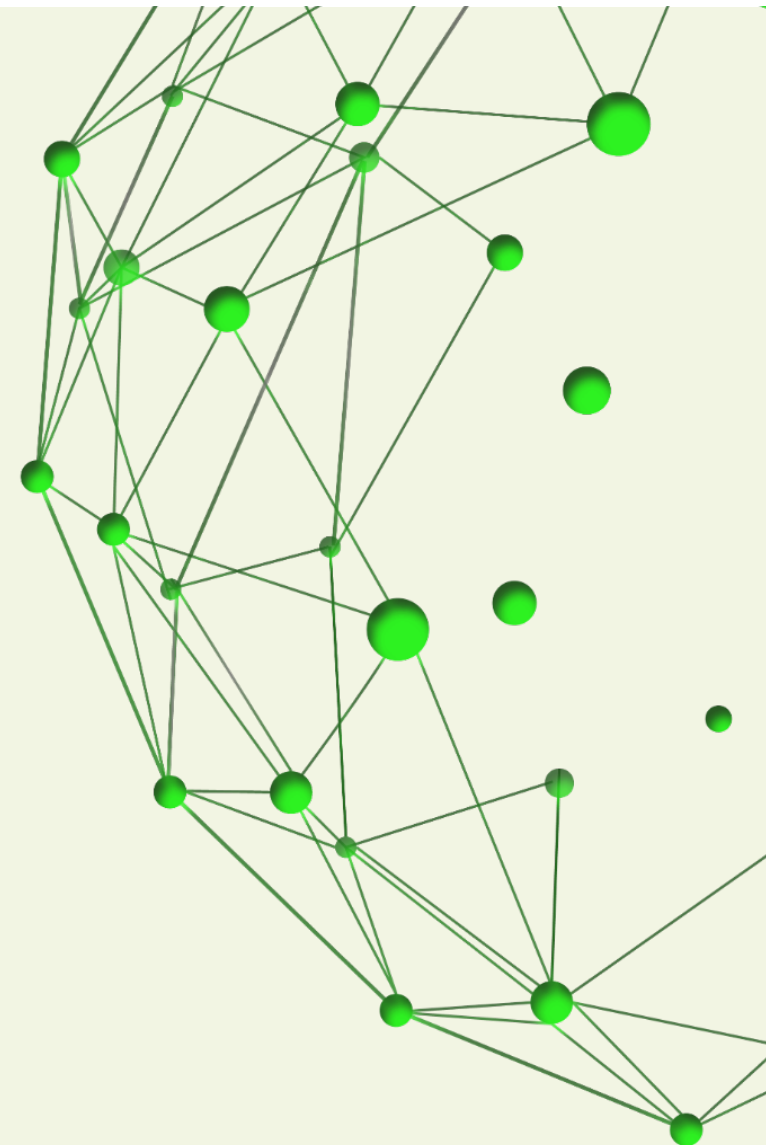

- Belgian origin means the product or practice originated from a Belgian entity.

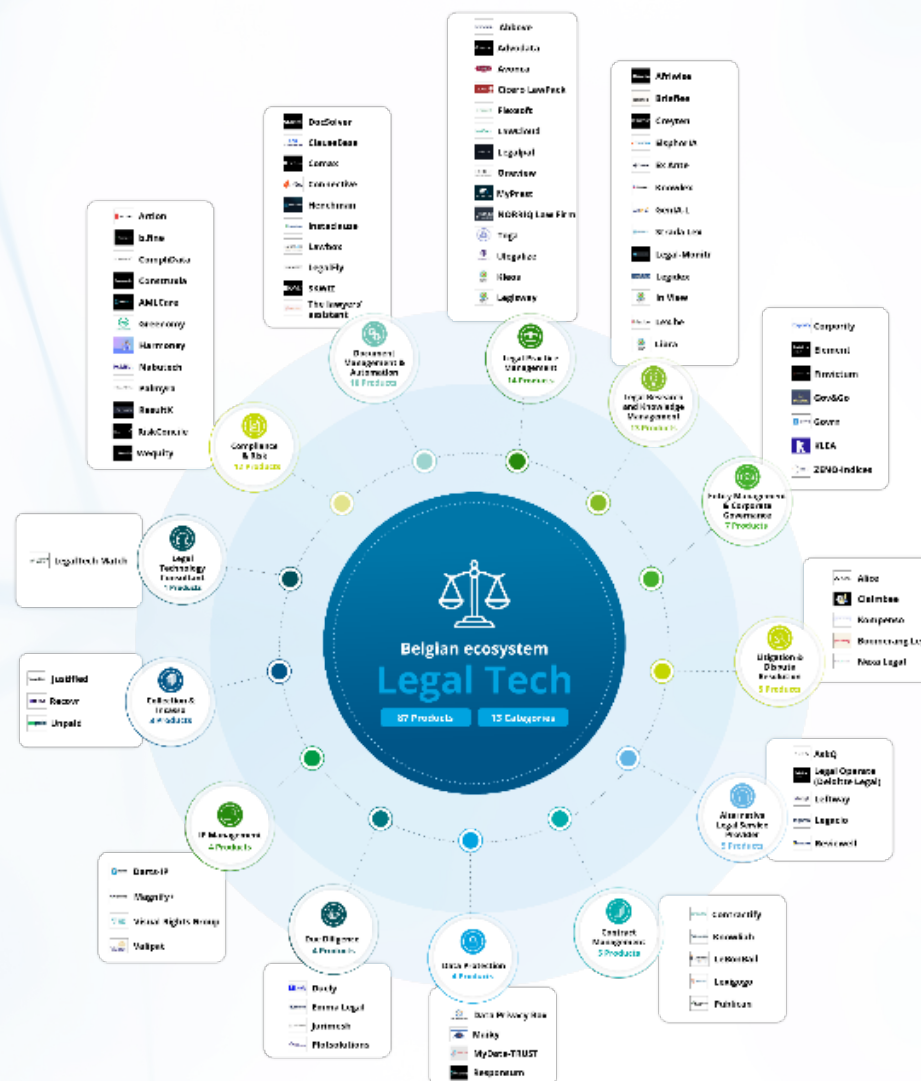
